Thank you for purchasing the (I)MFR-FANKIT-2. Please read these instructions thoroughly before installing/operating this product.

- Quietly removes heat directly from the source.

8	Push Rivets

5	Self-Adhesive Cable Mounts

INSTALLATION

- 1) Remove rear panel from rack. **(FIGURE A)**
- 2) Install fans using eight (8) push rivets as shown (4 per fan). **(FIGURE B)**

NOTE: Air flows in direction of arrow on fan housing.

- 3) Connect power cord to power supply.
- 4) If applicable, select and install appropriate wall plug adapter included with the power supply.

NOTE: Adapter must SNAP into place to be connected to the power supply.

- 5) Plug power supply into AC outlet. **(FIGURE B)**
- 6) Re-install rear panel.
- 7) Bundle wiring together with provided wire ties and secure to self-adhesive cable mounts.



